#### **Important Dates:**

- 1. Nomination Deadline: November 22, 2024
- 2. Nomination Withdrawal Deadline: December 2, 2024 (for withdrawal, email your request to <a href="mailto:election@pmimumbaichapter.org">election@pmimumbaichapter.org</a>)



## **Mandatory Eligibility Criteria:**

- 1. Must not hold a position on the Board/Committee of any other PMI Chapter during the term.
- 2. ATP Trainers are ineligible for Board positions.
- 3. Must reside in Mumbai, Thane, or Navi Mumbai and be available for physical meetings at the Chapter's office in Goregaon East.

## **General Expectations:**

- 1. Candidates should possess relevant skills, volunteer experience, and project management experience as outlined in the PMI MC Operational Handbook (v2.5).
- 2. Must attend 80% of Board/Chapter Committee Meetings on a pro-rata basis.
- 3. Preference will be given to candidates with a track record of contributions to chapter processes and teamwork.

#### **Election Process:**

- a. Positions will be filled via an electronic ballot.
- b. PMI Mumbai Chapter members eligible as of the date set will be able to nominate themselves and cast votes.
